

Not illustrated. 1827 Excerpt: ...Two weeks rent being in arrear from a weekly tenant, his landlord gave him notice to quit, and on his refusal to do so, distrained an article of furniture worth the amount of three weeks rent, when there was one of a like description, but of less value, and sufficient to cover the rent actually due:--Held, that the tenant was'entitled to recover in an action on the case, for an excessive distress. This was an action on the case for an excessive distress. At the trial, before the Lord Chief Justice, at Guildhall, at the sittings after the last term, it appeared that the plaintiff was the occupier of an unfurnished lodging, at 5s. per week; that two weeks rent were in arrear, when he had notice to quit; that he refused to do so, when the defendants distrained a table of the plaintiff's for 15.; three days after which he commenced the present action. It also appeared that they took a mahogany table, a deal one being in the room, which was sufficient to cover the two weeks rent due. The jury found a verdict for the plaintiff, damages 1. Mr. Serjeant Wilde now applied for a rule to show cause why this verdict should not be set aside, and a nonsuit entered;--and submitted, thaf this action could not be maintained, as the plaintiff held over after a notice to quit; and that his landlord was consequently entitled to double value. Besides, the difference in the amount was only 5s., and only a single article was taken. This action, therefore, was most vexatious and oppressive, and in point of strictness, could not be maintained.---But The Court held, that as 10. only were actually due, the distress for 15. could not be supported; that the plaintiff might have suffered an inconvenience, as he might have been able to pay the sum of 10., which was the amount due; and as...
